### **Purpose, what do we process your data for?**

AS foreseen in the RGPD of April 27, 2016, and LO 3/2018, we will treat the data we collect for the following purposes:

- Contact you if you ask us to do so.
- Manage your browsing on the web, if applicable.
- Send you commercial communications about our products and services.
- Manage purchases of products offered on the web added to the basket.

PROITEK will treat the following categories of User data:

- Identifying data: name, surname.
- Contact information: postal address, email address and telephone.

The completion of the registration form will be mandatory to access and enjoy certain services offered on the web. Failure to provide the requested personal data or not accepting this data privacy policy implies the impossibility of registering, subscribing or participating in any of the promotions in which personal data is requested.

### **Legitimation, what is the legitimacy for the processing of your data?**

The legal basis for the processing of your data will be based on:

- The consent of the interested party for the processing of their data, in accordance with article 6. 1. a) of the General European Data Protection Regulation. In this case, the consent and agreement entered into by the interested party through the contact form, by enabling the box "I accept the legal notice and privacy policy".



- The necessary execution of a contract in which the interested is a party or for the application at his request of pre-contractual measures, in accordance with article 6. 1. b) of the European General Data Protection Regulation.

### **Receiver. Who do we communicate your data to?**

Personal data will not be transferred except in compliance with legally established obligations or to support the services linked to this treatment.

### **Conservation. How long do we keep your data?**

We will keep your personal data for at least 5 years if you are a client and for strict compliance with the legal obligations established in the regulations.

If you are not a client, we will keep your data for the minimum time necessary to manage our relationship.

### **Rights. What are your rights when you provide us with your data?**

Anyone has the right to obtain the confirmation if the company is processing personal data that concerns them.

Interested persons have the right to access their personal data, as well as to request the rectification of inaccurate data or, where appropriate, request its deletion when, among other reasons, the data is no longer necessary for the purposes for which it was collected.

In certain circumstances, interested persons may request the limitation of the processing of their data, in which case we will only keep them for the exercise or defense of claims.

In certain circumstances and for reasons related to their particular situation, interested persons may object to the processing of their data. In this case, the data will stop being processed, except for legitimate reasons or the exercise or defense of possible claims.

Interested persons may request the portability of the data to obtain the data that has been provided in a structured, commonly used and machine-readable format, to be downloaded by themselves or transmitted to another entity.

These rights may be exercised by written communication, specifying:

- Name, surname and copy of the applicant's ID.
- Name, surname and copy of the representative's DNI, in the event that the procedure is carried out by one.
- List of reasoned reasons why the claim is made.
- Address for notification purposes.
- Date and signature of the applicant.
- Any other document that complements the application

### **Minor consents, what if you are a minor?**

In the event that some of our services are specifically aimed at minors under fourteen years of age, we will request the consent of parents or guardians for the collection of personal data or, where appropriate, for the automated processing of data in accordance with article 7 of the LOPDGDD.

### **Accuracy, veracity and security of the data, how do we treat your data?**

The User is solely responsible for the veracity and correctness of the included data, exonerating us from any responsibility in this regard. The users guarantee and are responsible in any case for the accuracy, validity and authenticity of the personal data provided, and undertake to keep them duly updated. The user agrees to provide complete and correct information in the registration or subscription forms. We will not be responsible for the veracity of the information that is not of our own elaboration and for which another source is indicated, for which reason it does not assume any responsibility for hypothetical damages that may arise from the use of said information.

We will also reserve the right to update, modify or eliminate the information contained in the web, and may even limit or deny access to said information.

We will not be responsible for any damage or harm that the User may suffer as a result of errors, defects or omissions in the information provided by the person in charge, if it comes from outside sources.

The data will be treated confidentially and subject to adequate technical and organizational security measures to avoid its alteration, loss, treatment or unauthorized access.
